What happened with the 2018 Donation?

So much good! We just received the project update from Etta Projects! Their update outlines just how our donation was used to help improve health in Bolivia. Etta Projects truly believes in involving the local government and community members, including women leaders, on all their projects. They provide partial funding, guidance and education to ensure these projects are self-sustaining and even more successful. The first project our donation helped with was to supply clean water to 50 homes in the rural community of San Miguel Ricon.

The second project also involved supplying clean water. This project provided 28 of the 32 homes in the small community of Guadalupe Palometilla. The need for a sanitation infrastructure in this village was imperative. For sewage disposal, most of the families were using a pit latrine or some open defecation. Gray water was disposed of either by dumping it around the house or directly into a nearby small river. By improving access to clean water, it will have significant beneficial impacts on this community's health.

Retail HACCP Validation and Verification

DOH and WSEHA are excited to announce that a two day course, provided by North Carolina State University, will be held at Renton Technical College in August. There are two training dates available – August 6-7 and August 8-9. In addition to the 2-day training, NC State offers an optional ½-day “Train the Trainer” course on Monday, August 5th.

The course uses hands-on and interactive activities to build on basic understanding of HACCP principles and to provide training in applying these principles. The course goals are to provide the tools and knowledge to identify special processes, skillfully review submitted HACCP Plan documentation, and gain a working knowledge of these processes to better help operators of retail food establishments. NC State encourages attendees to take the course material back to their home area and train additional people on HACCP review.



The DOH Food Safety Program is using an FDA-AFDO grant to provide scholarships to help cover the NC State registration costs for one food safety staff member from each LHJ. LHJs must claim their scholarship by July 1 or it will be awarded to other registrants. Staff from Colorado, Minnesota, Oregon, and a few other states are planning to attend and we believe this will be an excellent training and partnership opportunity. We hope you'll be able to send a member of your team.
