PRESIDENT'S MESSAGE: MIKE YOUNG

As president of WSEHA, I was recently asked by a representative from National Environmental Health Association (NEHA): What are the most pressing Environmental Health needs in your affiliate?

That's quite a question, I thought, who am I to represent such a vast field of professionals? Then I thought, I'll just answer because this will show that being a volunteer for an organization provides you an opportunity to make a difference. I also thought if I give a good answer, perhaps someone will be happy. If there was a better answer, someone will let me know, I'm sure. So... I went with - we could use more knowledge about **Environmental Health Resource Management.**

In this time of limited resources, our leaders and the public have asked for evidence they are getting the maximum benefit from public funding. Management is then compelled to show they placed the appropriate resources, such as number of inspectors, or number of inspections per year, most beneficially to serve public health. However, as we know, Environmental Health work is often preventive actions for good public health, which sometimes has no clear cause and effect. In these cases, management tends to only place resources allowed to them by policy makers when they have specific rules to address issues. In a perfect world, we would have performance measures tools that provide quantifiable readings directly from the community, used by Environmental Health managers to demonstrate there is a good effect, as a result of actions taken.

Finding good scientifically based performance measures to demonstrate good resource management is important but difficult to find. We should look for workable performance measures that utilize applied science, which can be used by local health agencies. If there are health jurisdictions who have found workable performance measure tools or have utilized some new applied science, we would like to hear about it at the next Annual Education Conferences (AEC) with WSEHA or NEHA. For example, are there communities who have successfully utilized rat maps to justify more solid waste compliance resources? Are there agencies who have food establishments with such good handling practices they have avoided outbreaks, while others did not? Has anyone successfully used DNA to remove human fecal contamination from a surface water concern? Environmental Health agencies should share what resource management tools have worked or what has not worked. Resources for the whole environmental health profession will only improve if we create these tools, which can in turn be used in education and lobbying.

Please let me know if you have better answers because you can make a difference. We are busy planning for the 2019 AEC in May on the east side of the Cascades, and your input is welcome as to the type of speakers and subjects discussed. We are also talking about the 2020 AEC on the west side of the mountain. If you want to make a difference and lead your profession in the years to come, please let us know why we should hold the AEC in your area.
