The position being filled is full time and will have an emphasis in Consumer Protection programs, such as retail food, public pools, body art, and cottage food. Here is a description of job classifications that are eligible to apply for the current job opening:

Registered Environmental Health Specialist I: This is the entry level position

in the classification series and as such is responsible for basic environmental health duties; you are required to have your California REHS and one year of responsible professional related experience in a public health agency.

Registered Environmental Health Specialist II: This is the journey level position in the classification series and you will be expected to handle professional duties with minimal supervision; you are required to have your California REHS and one year of responsible professional related experience in a public health agency.
